

FIRST AMENDMENT TO 28E AGREEMENT  
FOR FOOD PROCUREMENT ACTIVITIES

This First Amendment to 28E Agreement (hereinafter "Amendment") is made pursuant to Iowa Code Chapter 28E by and between the Anamosa Community School District, the Benton Community School District, the Clear Creek Amana Community School District, the English Valleys Community School District, the Iowa Valley Community School District, the Lone Tree Community School District, St. Joseph Catholic School, the Iowa City Community School District, and the Regina Inter-Parish Catholic Education Center.

WITNESSETH:

WHEREAS, except for the Regina Inter-Parish Catholic Education Center, the above-listed parties to this Amendment (hereinafter "Original Parties") have entered into a 28E Agreement for Food Procurement Activities, Filing No. M506096, to provide a means by which they may jointly and cooperatively engage in food procurement activities and, as applicable, fulfill their food procurement responsibilities for their respective school meal programs in accordance with applicable state and federal law governing such programs (hereinafter "Original Agreement");

WHEREAS, Section 20 of the Original Agreement provides that the Original Agreement may be amended upon mutual written agreement of the Original Parties, including an amendment for the addition of other school districts to the Original Agreement;

WHEREAS, the Regina Inter-Parish Catholic Education Center has expressed a desire to be added as a party to the Original Agreement and the Iowa City Rural Food Service Purchasing Group referred to therein; and

WHEREAS, the Original Parties wish to amend the Original Agreement to provide for the addition of the Regina Inter-Parish Catholic Education Center as a party to the Original Agreement and the Iowa City Rural Food Service Purchasing Group, and the Regina Inter-Parish Catholic Education Center wishes to be added as such a party and agrees to the terms and conditions set forth in the Original Agreement.

NOW, THEREFORE, in consideration of the mutual promises contained in this Amendment, the parties agree as follows:

Section 1. The Regina Inter-Parish Catholic Education Center shall be added as a party to the Original Agreement and the Iowa City Rural Food Service Purchasing Group referred to therein, and the Regina Inter-Parish Catholic Education Center agrees to the terms and conditions set forth in the Original Agreement, which is incorporated herein by reference.

Section 2. This Amendment, along with the Original Agreement and any other amendments thereto, represents the entire and integrated agreement between the parties. Except as amended herein or by any other amendments, all of the terms and conditions of the Original Agreement are in all respects ratified, confirmed, and approved and shall remain in full force and effect.

Section 3. This Amendment may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute the same instrument.

Section 4. This Amendment shall become effective upon the proper approval and execution of the Amendment by each party hereto and the filing of the Amendment with the Iowa Secretary State in accordance with the provisions of Iowa Code Section 28E.8.






